**SUPPLEMENT OF NEXUS COMMUNICATIONS, INC.  
TO THE NOTICE OF REACTIVATION AND AMENDMENT OF PETITION**

Nexus Communications, Inc. (“Nexus”) respectfully submits this supplement to the Notice of Reactivation and Amendment of Petition filed on December 28, 2012 (“Amendment”) in order to provide the Commission with additional information about the public interest benefits that will accrue by designating Nexus as an eligible telecommunications carrier (“ETC”) in both non-rural and rural areas of Kentucky.

Designating Nexus as an ETC in areas served by rural telephone companies will serve the public interest.<sup>1</sup> Among the principal goals of the Communications Act, as amended by the Telecommunications Act of 1996, are “to secure lower prices and higher quality services for American Telecommunications consumers and encourage the rapid deployment of new telecommunications technologies” to all citizens, regardless of geographic location or income.<sup>2</sup> Nexus’ request for ETC designation in both rural and non-rural areas must be examined in light of these goals. The addition of Nexus as a wireless service provider in rural parts of Kentucky will increase the number of ETCs serving those areas. Thus, the Commission will enable Nexus to increase the number of Kentucky residents living in rural areas receiving Lifeline support, thereby increasing the amount of USF money flowing into Kentucky. ETC designation in

Kentucky will enable Nexus to provide Kentuckians in rural areas increased consumer choice, high-quality service offerings, and mobility, as well as the safety and security of effective 911/E911 services.

For many years, Nexus' mission has been increasing access to basic telecommunications services for low income individuals that have been largely left behind by other carriers, as evidenced by the historically low penetration rate among low-income consumers. Nexus' subscribers are the many people who simply require affordable wireless service, but cannot readily obtain it from other carriers who do not provide the discounted plans available to a certified ETC. As set forth in Section VI of the Amendment, Nexus will offer a variety of wireless service plans and voice services at no out-of-pocket cost to qualified, economically disadvantaged Kentuckians who desire affordable wireless services. Nexus plays a critical role in the marketplace by ensuring that Americans who cannot qualify for or afford other carriers services can still enjoy the benefits of wireless communications.

The need for such services is particularly acute in the rural areas of Kentucky. Estimates from 2010 indicate that a poverty rate of 22.9% exists in rural Kentucky, compared to 16.0% in urban areas of the state,<sup>3</sup> and Kentucky's rural areas also have significantly higher levels of unemployment than its urban areas.<sup>4</sup> Thus, designation of Nexus as an ETC in rural areas will bring Lifeline-supported services to those areas of the Commonwealth where it is most needed.

The public interest benefits of Nexus' wireless service include larger local calling areas (as compared to traditional wireline carriers), the convenience and security afforded by mobile telephone service, the opportunity for subscribers to control cost by receiving a preset amount of

monthly airtime at no charge, the ability to purchase additional usage at flexible and affordable amounts in the event that included usage has been exhausted, 911 service and, where available, E911 service in accordance with current FCC requirements. Nexus' Lifeline subscribers will receive the same high-quality wireless services and exceptional customer service provided to all Nexus subscribers. Nexus' Lifeline rate plans will not only allow feature-rich mobile connectivity for qualifying subscribers at no cost to the subscriber, but also will bring a variety of rate plans into the reach of Lifeline subscribers that are comparable in minutes and features to those available to post-paid wireless subscribers – but at low Lifeline-supported rates and without the burden of credit checks or exhaustive contracts.

Nexus' Lifeline program will provide low-income Kentucky residents in rural and non-rural areas with the convenience and security offered by wireless services. The economic circumstances indicate that low-income individuals, now more than ever, can greatly benefit from the advantages offered by Nexus' Lifeline service, thus allowing those adversely impacted by the failing economy or job loss to have access to a free wireless service to assist in emergency situations, facilitate job search efforts, and to maintain contact with family members. In short, providing Nexus with the authority necessary to offer discounted Lifeline services to those most in need of wireless service altogether undoubtedly promotes the public interest – especially in areas with high levels of poverty and unemployment such as rural Kentucky.

Finally, Nexus recently was honored to have been selected by the FCC to participate in its broadband pilot program. Nexus is committed to being a long-term provider of Lifeline-supported services, including eventually Lifeline-supported *broadband* services. In December 2012, Nexus was selected as one of the fourteen ETC participants in the FCC's pilot project to


expand the Lifeline program to funding broadband services.<sup>5</sup> Nexus recognizes that, like other universal service programs, Lifeline eventually will be transitioned to funding broadband services. Nexus' participation in the pilot program will assist the FCC in determining the level of subsidy necessary to increase broadband adoption among low income Americans. Nexus will be providing the pilot broadband services in eight states including California, Louisiana, Michigan and its home state of Ohio. It will partner with Connected Nation to provide digital literacy training to pilot participants. By participating in the FCC's broadband pilot program, Nexus will gain valuable first-hand experience in the delivery of broadband services to Lifeline subscribers. Nexus expects that lessons learned from the pilot program eventually will lead to its offering Lifeline-supported wireless broadband services in Kentucky, consistent with the efforts of other stakeholders to expand the availability and adoption of broadband services throughout the Commonwealth of Kentucky – particularly rural parts of the Commonwealth where the number of wireline broadband providers may be limited.
