**Joint Motion to Extend Deadline for Filing Procedural Schedule and
Request for Expedited Treatment**

New Cingular Wireless PCS, LLC d/b/a AT&T Mobility and its operating affiliates, (collectively, "AT&T Mobility") and Windstream Kentucky East, LLC ("Windstream") hereby file their Joint Motion to Extend Deadline for Filing Procedural Schedule. The Parties request the Kentucky Public Service Commission ("Commission") extend the deadline from January 25, 2011, to February 8, 2011, for filing an updated Procedural Schedule in the captioned matter to allow the Parties an opportunity to discuss and work to resolve issues regarding the preparation of a new traffic study in this matter as ordered by the Commission. Input of the appropriate business parties is required, since preparation of the traffic study includes complex issues, the resolution of which is necessary in order for a valid traffic study to be prepared.

The Parties, therefore, request that the Commission extend the current deadline for filing a Procedural Schedule to February 8, 2011. Because of the short time-frames involved, the Parties request that this motion be given expedited treatment.

WHEREFORE, the Parties respectfully request that their Motion to Extend Deadline for Filing Procedural Schedule and Request for Expedited Treatment be granted.


