RE: Informal Conference of November 18, 2010

An informal conference was conducted at the Commission's offices on November 18, 2010. A list of the attendees is attached hereto.

An Order was issued by the Commission on November 10, 2010 directing Blue Grass Energy Cooperative Corporation ("Blue Grass Energy") to publish once a week for three consecutive weeks, in newspapers that meet the requirements of KRS 424.120, notice of its proposed revisions to its residential security deposit rate in certain of its service areas; and to file with the Commission, by December 7, 2010, an affidavit from each publisher verifying that the aforementioned notice had been published. including the dates of publication with an attached copy of the published notices. The Order further directed Blue Grass Energy and the Kentucky Cable Television Association ("KCTA") to notify the Commission in writing by November 17, 2010 whether it desired an informal conference to discuss the rate application, whether the issues presented in the rate application may be submitted on the record, and whether the necessity of a formal hearing exists.

On November 15, 2010, counsel for Blue Grass Energy contacted Commission Staff and indicated that Blue Grass desired an informal conference. On November 16. 2010, a Commission Staff Notice of Informal Conference was issued; and on November 17, 2010, Blue Grass Energy filed its written Motion for an Informal Conference.

The purpose of the Informal Conference was to discuss the issues presented in the rate application. Also, Blue Grass Energy discussed its motion to postpone the hearing date and its motion to extend the time for filing of affidavits from publishers.

Blue Grass Energy indicated that it had already begun to publish notice in certain newspapers but that it could not have an affidavit of publication submitted confirming publication by December 7, 2010. A copy of certain publication information from the Kentucky Press Association offered by Blue Grass Energy at the informal conference is attached hereto.

Counsel for Blue Grass Energy and counsel for the Kentucky Cable Television Association (KCTA) indicated that an agreement with regards to the proposed cable television attachment (CATV) rates had been reached and that the settlement agreement would be filed with the Commission.

Blue Grass Energy suggested that a postponement of the hearing date is appropriate in order to allow it time in which to accomplish the publication required and to submit the appropriate affidavits.

The rate suspension ending date of January 7, 2011 was also discussed, particularly with regards to the 30 day time frame provided in the regulation allowing an interested party thirty days after final publication in which to file a petition for intervention.
