

MOTION FOR EXTENSION OF TIME TO FILE
LOAD FORECAST AND OTHER INFORMATION

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by counsel, and moves the Kentucky Public Service Commission (the "Commission") for an Order extending the deadline for the filing of EKPC's 2010 load forecast and other information required by the Commission's June 22, 2010 Order. EKPC respectfully requests that the Commission enter an Order requiring that the 2010 load forecast and other information requested be filed on or before November 30, 2010.

In support of this Motion, EKPC states that all of the parties to this case have worked diligently over the past three months to negotiate a global settlement of all the issues presented by the Commission's Order initiating this investigation as well as other issues which are related thereto but not specifically a part of this case. The parties participated in an informal conference at the Commission's offices on November 9, 2010 wherein they advised Commission Staff that they believe they have concluded a settlement of all issues in this case as well as many others. However, because of the time and resources which EKPC has been required to devote to the discussions leading to the settlement, it has not been able to finally complete the 2010 load forecast and other information requested by the Commission's June 22, 2010 Order.

However, counsel for EKPC advised Commission Staff and the other parties of his belief that EKPC could file this documentation on or before November 30, 2010. This additional time is needed to complete the Settlement Agreement, obtain all signatures of the parties and file same with the Commission. Following this filing, EKPC will be able to devote its full attention to completion of the 2010 load forecast and other information for filing on or before November 30.

At the informal conference on November 9, 2010, the other parties to this case verbally advised the Commission Staff that they had no objection to this extension of time.

WHEREFORE, EKPC respectfully requests that the Commission enter an Order extending the time for the filing of EKPC's 2010 load forecast and other information requested by the Commission's June 22, 2010 Order, and require that same be filed at the Commission on or before November 30, 2010.
