NOTICE AND MOTION TO ACCEPT RELINQUISHMENT OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, and herewith notifies the Kentucky Public Service Commission ("Commission") of its intention to abandon the construction of the 278 MW Smith Circulating Fluidized Bed Generating Unit ("Smith 1") which was to be built at Trapp, Clark County, Kentucky, on property owned by EKPC. Further, EKPC notifies the Commission of its intent to relinquish the Certificate of Public Convenience and Necessity ("CPCN") which the Commission granted by Order on August 29, 2006 in Case No. 2005-00053, permitting EKPC to construct Smith 1. EKPC respectfully requests that the Commission enter an Order accepting this relinquishment of the Smith 1 CPCN and setting aside its previous grant by the Commission.

In support of this Notice and Motion, EKPC relies upon, and specifically incorporates by reference herein, its 2010 Load Forecast, testimony and other information and documentation which is being filed contemporaneously in this docket. Collectively, these filings demonstrate that EKPC's load growth has experienced a significant downward trend and it is now projected that new base load generation is not needed on the EKPC system until at least 2018. In addition, Smith 1 is no longer the least cost option for EKPC compared to other power supply alternatives,

and building Smith 1 would place an undue burden on EKPC from a long-term debt perspective, and would cause EKPC's rates to its members to increase substantially.

In further support of this Notice and Motion, EKPC refers the Commission to the Settlement Agreement by and between EKPC, Gallatin Steel Company, the Kentucky Attorney General, Wendell Berry, Dr. John A. Patterson, M.D., MSPH, and Fr. John Rausch which is also being filed this date.

WHEREFORE, EKPC herewith notifies the Commission of its intention to abandon the construction of Smith 1 CFB, to relinquish the CPCN, and requests that the Commission enter an Order setting aside its previous grant of the CPCN.
