Pursuant to the Commission's October 14, 2010 Order, an Informal Conference ("IC") was scheduled with Big Rivers Electric Corporation ("Big Rivers") on December 2, 2010. Big Rivers' representatives participated via telephone conference. Representatives of Big Rivers and Staff discussed Big Rivers' responses to the first round of data requests in the current examination of the company's environmental surcharge mechanism. A list of attendees from Big Rivers and Staff is attached to this memorandum.

Staff asked a few clarifying questions related to information included in the first data request. The topics discussed were related to the summary schedule of pass-through amounts for non-dedicated delivery point customers of the Member Cooperatives in response to Item 2 of the data request.
