# DUKE ENERGY KENTUCKY, INC.'S MOTION TO SCHEDULE AN INFORMAL CONFERENCE AND AMEND PROCEDURAL SCHEDULE

Comes now Duke Energy Kentucky, Inc. ("Duke Energy Kentucky"), by counsel, and hereby tenders a motion to schedule an informal conference and to amend the procedural schedule, respectfully stating as follows:

1. On June 17, 2011, the Commission issued a procedural schedule in this matter authorizing the parties to tender initial and supplemental data requests. Duke Energy Kentucky timely filed its response to the Commission's initial data requests, but the complainant, Bulldog's Enterprises, Inc. d/b/a Bulldog's Road House ("Bulldog"), failed to do likewise. The Commission subsequently amended its procedural schedule on July 28, 2011 to allow Bulldog to tender responses to the Commission's initial data requests. As of this date, Duke Energy Kentucky has not received a copy of Bulldog's responses to the Commission's initial data requests.

Pursuant to the July 28, 2011 procedural order, Duke Energy Kentucky's supplemental data requests are currently due to be tendered on August 15, 2011. Duke Energy Kentucky cannot adequately prepare its supplemental data requests, however.

until it has had a reasonable opportunity to review Bulldog's responses to the

Commission's initial data requests.

3. Duke Energy Kentucky respectfully requests the Commission to schedule

an informal conference on a date and at a time convenient to the Commission Staff for

the purpose of discussing the procedural posture of this case, the relationship of this

proceeding to a matter currently pending in the Kenton Circuit Court, and any other

issues which may be appropriate for consideration.

Duke Energy Kentucky also respectfully requests the Commission to 4.

amend the procedural schedule to extend the deadline for tendering supplemental data

requests so as to allow Duke Energy Kentucky a reasonable period of time in which to

first review Bulldog's responses to the Commission's initial data requests.
