O R D E R

On November 15, 2010, Green-Taylor Water District (“Green-Taylor”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Green-Taylor purchases water from the city of Greensburg (“Greensburg”) and from Green River Valley Water District (“Green River Valley”).

2. Greensburg notified Green-Taylor that Greensburg’s wholesale water rate to Green-Taylor would increase from \$1.839 per thousand gallons to \$2.206 per thousand gallons, effective August 1, 2010.

3. Green River Valley notified Green-Taylor that Green River Valley’s wholesale water rate to Green-Taylor would increase from \$1.58 per thousand gallons to \$2.14 per thousand gallons, effective December 1, 2010.

4. Green-Taylor proposes to increase the water rates to its customers effective December 1, 2010.

5. During the 12 months ending October 31, 2010, Green-Taylor purchased a total of 207,796,770 gallons of water from Greensburg and 38,438,500 gallons from Green River Valley, and sold 290,548,680 gallons. The increase in the cost of purchased water is \$97,786.97, resulting in a purchased water adjustment of \$0.34 per 1,000 gallons.

6. The purchased water adjustment of \$0.34 per 1,000 gallons is fair, just, and reasonable and should be approved.

7. The amended tariff sheets that Green-Taylor filed on November 30, 2010 do not contain the same rate design as its present rates.

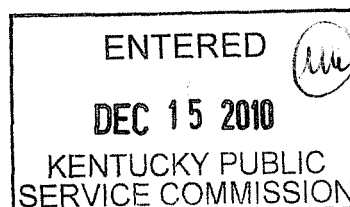
IT IS THEREFORE ORDERED that:

1. The rates proposed by Green-Taylor are approved.
2. The purchased water adjustment of \$0.34 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are approved for service that Green-Taylor renders on or after December 1, 2010.
4. Within 20 days of the date of this Order, Green-Taylor shall file revised tariff sheets with the Commission that reflect the approved rates.
