Application of Kenergy Corp. for an Adjustment in Existing Rates

Pursuant to the Commission Staff's notice of June 29, 2011, an informal telephonic conference was held on June 30, 2011. A list of the attendees is attached hereto.

The purpose of the informal conference was to discuss the terms of the tentative settlement between Kenergy Corp. ("Kenergy") and the Kentucky Industrial Utility Customers, Inc. ("KIUC"). Representatives of Kenergy provided an overview of the material terms of the settlement. Commission Staff asked several clarifying questions regarding the settlement, including the need for provisions to address depreciation rates, non-recurring charges and CATV fees. Commission Staff also asked Kenergy about the date it would file updated exhibits to reflect the recent change in Kenergy's fuel adjustment clause ("FAC") as requested in Commission Staff's Fourth Information Request. The parties agreed to make the necessary changes to the settlement agreement and Kenergy stated that the exhibits impacted by the change in their FAC rate would be filed by Friday July 1, 2011 or Tuesday, July 5, 2011. Lastly, Commission Staff discussed certain procedural aspects relating to the formal hearing.

There being no further discussions, the conference was adjourned.
