
O R D E R

On June 30, 2011, Kentucky Industrial Customers, Inc. ("KIUC") filed a motion for a deviation, pursuant to 807 KAR 5:011, Section 14, from the requirement to file in paper format an original and ten copies of its responses to a limited number of data requests. KIUC states that some or all of its responses to the request of Big Rivers Electric Corporation, Item Nos. 28, 30, 33, 34, 35, and 38, and to the request of the Commission, Item No. 9, are voluminous, amounting to over 400,000 pages per copy, and that paper copies would be burdensome for both KIUC and the Commission. Further, KIUC states that it will file all of its responses to data requests in electronic format.

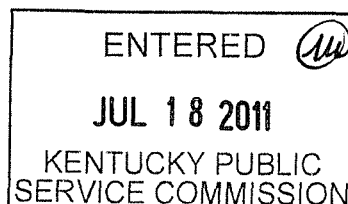
Based on the motion and being otherwise sufficiently advised, the Commission finds good cause to grant KIUC's motion and allow the filing in electronic format only of the voluminous responses to data requests.
