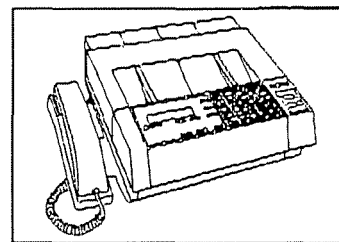


Comes Jackson Purchase Energy Corporation ("JPEC"), by and through counsel and states as follows:

Whereas, on June 8, 2011, JPEC filed an Application, pursuant to KRS 278.455(2), with this Commission for approval of rates to flow-through an increase requested by its wholesale supplier, Big Rivers Electric Corporation ("Big Rivers"), in Case Number 2011-00036. This Commission, by Order dated November 17, 2011, approved a rate increase for Big Rivers which rates are to be effective September 1, 2011. Further, on the same date, this Commission entered an order approving the flow-through rates for JPEC.

On December 6, 2011, Big Rivers requested, pursuant to KRS 278.400, a rehearing on various issues. As such, JPEC hereby formally requests if the Commission modifies its Order dated November 17, 2011 as a result of Big Rivers' Petition for Rehearing, that the Commission modify its Order in this matter as appropriate.


