An informal conference was held in this matter on Monday, May 16, 2011. Representatives of Louisville Gas and Electric Company ("LG&E") and Commission Staff were present for this meeting. An attendance list is attached. The purpose of the conference was to discuss the incident involved in this case.

The conference was opened by Commission Staff. LG&E was asked whether it had implemented any changes as a result of this accident. Representatives of LG&E proceeded to describe some changes that were made, including requiring the contractor in question to conduct refresher training on the derrick truck to its employees. Safety audits are already being conducted on a regular basis.

Settlement negotiations were also discussed and the meeting was adjourned.
