**RE:** Informal Conferences of November 4, 2011 and November 7, 2011

Pursuant to a joint motion filed by Kentucky Utilities Company and Louisville Gas and Electric Company, the Commission issued an Order on November 1, 2011, scheduling an Informal Conference (“IC”) for November 4, 2011, for purposes of discussing a possible resolution of the issues in these two cases. An IC was conducted at the Commission’s offices as scheduled on November 4, 2011. A list of attendees to the November 4, 2011 IC is attached to this memorandum.

The parties discussed the issues in the cases, but failed to reach an agreement by the end of the day.
