Pursuant to K.R.S. Section 278.310 and 807 KAR 5:001 Section 3(8), the United States Department of Defense and Other Federal Executive Agencies ("DOD/FEA"), by and through its duly authorized legal counsel, hereby files this Petition For Full Intervention in the above-captioned proceeding. In support of this Petition, DOD/FEA states:

1. DOD/FEA operates several major military and civilian installations and facilities in the service area of Louisville Gas And Electric Company ("LG&E") including, most notably, Fort Knox. Currently, Fort Knox alone pays LG&E over \$10,000,000 annually for electricity service. In view of the large increase requested by LG&E, the outcome of this proceeding will have substantial and significant impact on Fort Knox and the other affected Federal installations and facilities. The special interests of DOD/FEA cannot be adequately represented by any other party to this proceeding and DOD/FEA's full participation is likely to assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings.

Accordingly, DOD/FEA should be granted full intervenor status.


