In the following I have furnished the conversation as best as I remember. the information is correct but maybe not in the exact sequence of the conversation.

Purpose of call to Hillridge:

trying to locate where the sewer line connects to main line.

March 2-11

Call to Hillridge

Bob: this is Bob Carter

I live at 3902 Lethbridge Ct., Homestead, Ky.
Had some sewer work and need to
locate the port (where my line connects
to the main sewer line). Do you have info.

Hillridge:
(Person at Hillridge) You should call us not a plumber.
We have a contractor to do that work.

Bob: I have my own plumber.

Hillridge: Wanted to send Joe out right away.
He will come in and check your line.
He will call you.

Bob: My line is open now.
Line cleanout plug is damaged - can't
open. Will have to drill to open - No time

Hillridge: How did you clean out.

Bob From the vent on the roof.
Eric ran 150 ft. of line and would
like to know if he had got close to
Main sewer. We are just trying to
find point of connection. Don't need
your help inside.

Hillridge: We need to check it out.

Bob: Listen -- I don't need your help inside
I have a plumber,
I have company until Tuesday.

Hillridge I will have Joe call you and set up a time

Bob: Listen - All I need is some information.
End of Call - I hung up.

Note: Joe Murphy did call 2-3 times
My wife took the call - I was out.

3-21-11 Later I called Joe and explained
the situation to him.

His response: If I can help - give me a call.

Ref. Note: Hillridge explained to me - Mark Red
I don't remember part pertain to
camera line; or check line in street
Hillridge seems to have an
attitude problem.
