Informal Conference

An informal conference was held in this matter on Thursday, December 1, 2011. Representatives of South Kentucky R.E.C.C. ("South Kentucky") and Commission Staff were present for this meeting. An attendance list is attached. The purpose of the conference was to discuss the incident involved in this case.

The conference was opened by Commission Staff. South Kentucky was asked whether it had implemented any changes as a result of this accident. Representatives of South Kentucky proceeded to describe some changes that were made, including company-wide safety training on clearance issues and an emphasis on National Electric Safety Code (NESC) clearance issues during the inspection process.

Settlement negotiations were also discussed and the meeting was adjourned.
