
Re: Milburn Water District 2011 Rate Case Filing

Dear Sirs:

Attached please find an original and 10 copies of Milburn Water District's Alternative Rate Filing, including a notice to customers and mailing verification. In addition, please incorporate by reference in this case Milburn's annual reports on file with the PSC. Milburn is proposing that the new rates become effective on December 1, 2011, and has provided a proposed tariff to that effect in the attachments to this filing. In addition, Milburn has attempted to the best of its ability to fully comply with the Commission's ARF filing requirements. However, please consider this a request for waiver of any filing requirements which Milburn may have inadvertently overlooked, on the grounds that all relevant information has been provided to allow the processing of this case to begin.

Finally, please note that Milburn has very low cash levels, and is therefore respectfully requesting that the Commission expedite the processing of this case if at all possible. We have therefore included a separate volume of information which includes the 2010 customer billing records, to allow the PSC Staff to verify the billing analysis. We also believe that reduction of the rate case expenses associated with this application is in the best interests of all parties. Therefore, we respectfully request that the Commission Staff perform a field review rather than issuing data requests in order to process this case.
