ORDER

On November 4, 2011, Green Hills Water District ("Green Hills") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Green Hills purchases water from Pineville Utility Commission ("Pineville").
2. Pineville increased its volumetric wholesale rate to Green Hills from \$1.97 per 1,000 gallons to \$2.42 per 1,000 gallons on September 1, 2011.
3. Green Hills proposes a purchased water adjustment factor of \$0.51 per 1,000 gallons to be applied to its rates.
4. During the 12 months ending September 30, 2011, Green Hills purchased 32,734,000 gallons of water from Pineville and sold 29,168,182 gallons of water.
5. The purchased water adjustment factor of \$0.51 per 1,000 gallons is fair, just, and reasonable and should be approved.

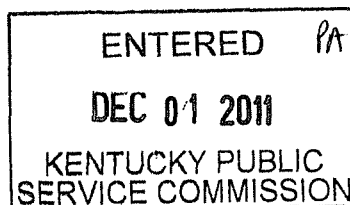

6. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that Green Hills renders on and after November 25, 2011.


IT IS THEREFORE ORDERED that:

1. Green Hills' proposed rates are approved.
2. The purchased water adjustment factor of \$0.51 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are approved for service rendered on or after November 25, 2011.
4. Green Hills' proposed tariff sheet filed with the application is approved.
