ORDER

On August 31, 2012, Kentucky Frontier Gas, LLC ("Frontier"), with the stated agreement of counsel for Harry Thompson, Thompson Energy et. al., and Other Unknown Entities ("Respondents"), moved to hold this proceeding in abeyance. In support of its motion, Frontier states that the parties met on August 30, 2012 in an attempt to resolve the issues and intend to continue efforts to reach a final agreement. Frontier asserts that further action by the Commission pending the outcome of these discussions could be unnecessary. Currently pending before the Commission is Frontier's motion to compel responses to its discovery request submitted to Respondents on June 11, 2012, pursuant to the Commission's procedural Order of June 7, 2012.

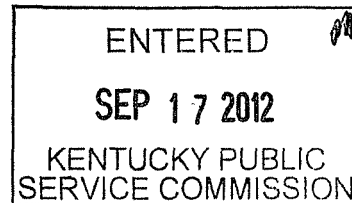
Having considered the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted.

IT IS THEREFORE ORDERED that:


1. This proceeding shall be placed in abeyance.
