SUBJECT: May 31, 2012 Telephonic Informal Conference

A Telephonic Informal Conference (“IC”) was held in this case at the Commission’s offices on May 31, 2012. A list of those participating is included in the Attachment to this memorandum. The IC had been requested by Commission Staff (“Staff”) for the purpose of discussing issues related to deficiencies in the application filed by Johnson County Gas (“Johnson County”) in this proceeding.

The IC attendees discussed the notice previously published for this case, which contained incorrect current rates. A discussion was held on which rates needed to be included in a new notice to be published in this case, as well as any additional information that would be required in this notice.

Counsel for Johnson County inquired about the debt amortization schedule that was required for this type of filing. Discussions were held on what information would be needed to satisfy this requirement.

Discussions were also held regarding the billing analysis required to be filed with this application. Counsel for Johnson County Gas advised Staff that he was working with Johnson County Gas to compile the information..

The conference was then adjourned.
