O R D E R

On October 21, 2010, in Case No. 2010-00116,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On June 18, 2012, Delta filed its proposed GCA to be effective July 23, 2012.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.2759 per Mcf, which is a decrease of \$1.1493 per Mcf from the previous EGC of \$6.4252 per Mcf.
3. Delta's notice sets out a current quarter Refund Adjustment ("RA") of (\$.0785) per Mcf. Delta's total RA is (\$.1294) per Mcf, which is a decrease of \$.0630 per Mcf from the previous quarter total RA of (\$.0664) per Mcf.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.6271) per Mcf. Delta's total AA is \$1.1193 per Mcf, which is a decrease of \$.2987 per Mcf from the previous total AA of \$1.4180 per Mcf.

5. Delta's notice sets out a Balance Adjustment ("BA") of \$1.8514 per Mcf, which represents an increase of \$1.1392 per Mcf from the previous BA of \$.7122 per Mcf.

6. Delta's GCA is \$8.1172 per Mcf, which is a decrease of \$.3718 per Mcf from the previous GCA of \$8.4890 per Mcf.

7. The GCA rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 23, 2012.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after July 23, 2012.


