ORDER

On July 31, 2012, Atmos Energy Corporation ("Atmos") filed with this Commission its annual Application to establish Pipe Replacement Program ("PRP") Rider rates for the 12-month period beginning October 1, 2012. On September 20, 2012, Atmos provided revised Exhibits and rates following a September 13, 2012 telephonic informal conference with Commission Staff.¹ There are no intervenors in this proceeding. The case now stands submitted for decision.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that the information contained in Atmos's application, along with its revised Exhibits in its September 20, 2012 supplemental filing, is in sufficient detail to support the reasonableness of Atmos's proposed PRP Rider rates.

IT IS HEREBY ORDERED that:

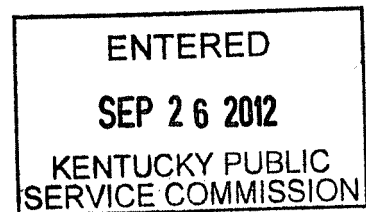
1. The PRP rates in the Appendix to this Order are approved for service rendered by Atmos on and after October 1, 2012.
