Filing Deficiencies

The Commission Staff has reviewed Fleming-Mason Energy Cooperative, Inc.'s response received 10/23/2012 in the above case. The filing remains deficient for the reason(s) set forth below:

Filing deficiencies pursuant to:

- (1) 807 KAR 5:001 Section 10(1)(b)(8) - Proposed tariff changes shown either by providing present and proposed tariffs in comparative form or indicating additions and deletions by italicized inserts or underscoring and striking over deletions in a copy of the current tariff.

Schedule RSP – TOD and Inclining Block, Original Sheets 1E and 1F are proposed new tariffs and rates and should be denoted by "N".

Schedule RSP (Residential) contains a proposed increase in the Minimum Charge section for temporary or seasonal service. There is a T to the right of the section which indicates a charge of \$180, indicating a text change in both the proposed tariff and the comparative tariff. Neither tariff indicates the proposal to increase the temporary or seasonal charge from the existing level of \$129.96.

At the bottom of the tariff sheets where the language “Issued by authority of an order of the Public Service Commission of Kentucky” appears, Case No. 2012-00369 appears and the date “10/23/12” is typed in. As the Order affecting the rates has not yet been issued in Case No. 2012-00369, that line should remain blank until the date of the Order affecting the rates in 2012-00369 is established.

- (2) 807 KAR 5:001 Section 10(3)(b) - Present and proposed rate for each customer class to which change would apply. The increased charge for temporary and seasonal service is not set out in the notice.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission. If your filing contains a proposed effective date, the rejection of your filing for reasons of deficiencies voids that proposed effective date. When you file the required information to correct the deficiencies, you may re-file your proposed tariff with a new proposed effective date that is a least 30 days from the date you file the required information. You are requested to file 10 copies of this information within 10 days of the date of this letter.
