Filing Deficiencies

The Commission Staff has reviewed Grayson R.E.C.C.'s application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

807 KAR 5:001, Section 10(3)(a)

1. The overall increase amounts do not always match the revenue increases in the billing analysis in Exhibit J.

807 KAR 5:001, Section 10(3)(c)

1. Electric, gas, water and sewer utilities – effect upon average bill for each customer class to which change will apply. The increase amount for Schedule 18 of \$57.04 is actually the average bill at the proposed new rates. The increase amount and percentage increase are both based on the proposed average monthly bill (\$57.04) rather than the increase per Exhibit J (\$9.91).

807 KAR 5:001, Section 10(1)(b)(7)

1. Schedule 11 - the on-peak energy charge on tariff does not match the on-peak energy charge in the notice,
2. Schedule 12(b) –the energy charge on the tariff does not match the notice,
3. Schedule 14(c) – the customer charge on the tariff does not match the customer charge on the notice, and
4. Schedule 16 – the energy charge on the tariff does not match the energy charge on the notice.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission. If your filing contains a proposed effective date, the rejection of your filing for reasons of deficiencies voids that proposed effective date. When you file the required information to correct the deficiencies, you may re-file your proposed tariff with a new proposed effective date that is a least 30 days from the date you file the required information.
