AMENDED PETITION

Comes now Grayson Rural Electric Cooperative Corporation (Grayson), by and through counsel, and for its amended petition herein states as follows:

1. The Petitioner adopts, reiterates, and realleges each and every paragraph and previous allegations set forth in its Petition and First Amended Petition, except as inconsistent herewith.
2. Petitioner states that it has entered into a tentative understanding with another entity for the purchase of 9.3 megawatts of power known as the Morgan Stanley Capital Group, Inc.
3. The proposed tentative arrangement is as set forth in a draft thereof attached hereto styled "Power Purchase Agreement Between Morgan Stanley Capital Group, Inc. and Grayson Rural Electric Cooperative Corporation".
4. Petitioner, pursuant to applicable regulations, seeks an order from the Commission directing that the attached Power Purchase Agreement in its form as attached and as may

be supplemented by more specific information relative to price and other monetary consideration, be granted confidential treatment by the Commission.



The specific grounds for the request for confidential treatment include that the attached Power Purchase Agreement sets forth information and material that is generally recognized as confidential and proprietary and which if openly disclosed would permit an unfair commercial advantage to competitors of the entity with whom Grayson proposes to contract.
6. Attached hereto is, under seal, the Power Purchase Agreement giving rise to the filing of this Amended Petition and for which the request for confidential treatment is based. The entire Power Purchase Agreement should be afforded confidential treatment pursuant to all of the foregoing and applicable regulations and Kentucky statutory authority.
7. There is also attached hereto a redacted portion of the entire Power Purchase Agreement.

WHEREFORE, Grayson tenders its Amended Petition herewith and requests for confidential treatment.



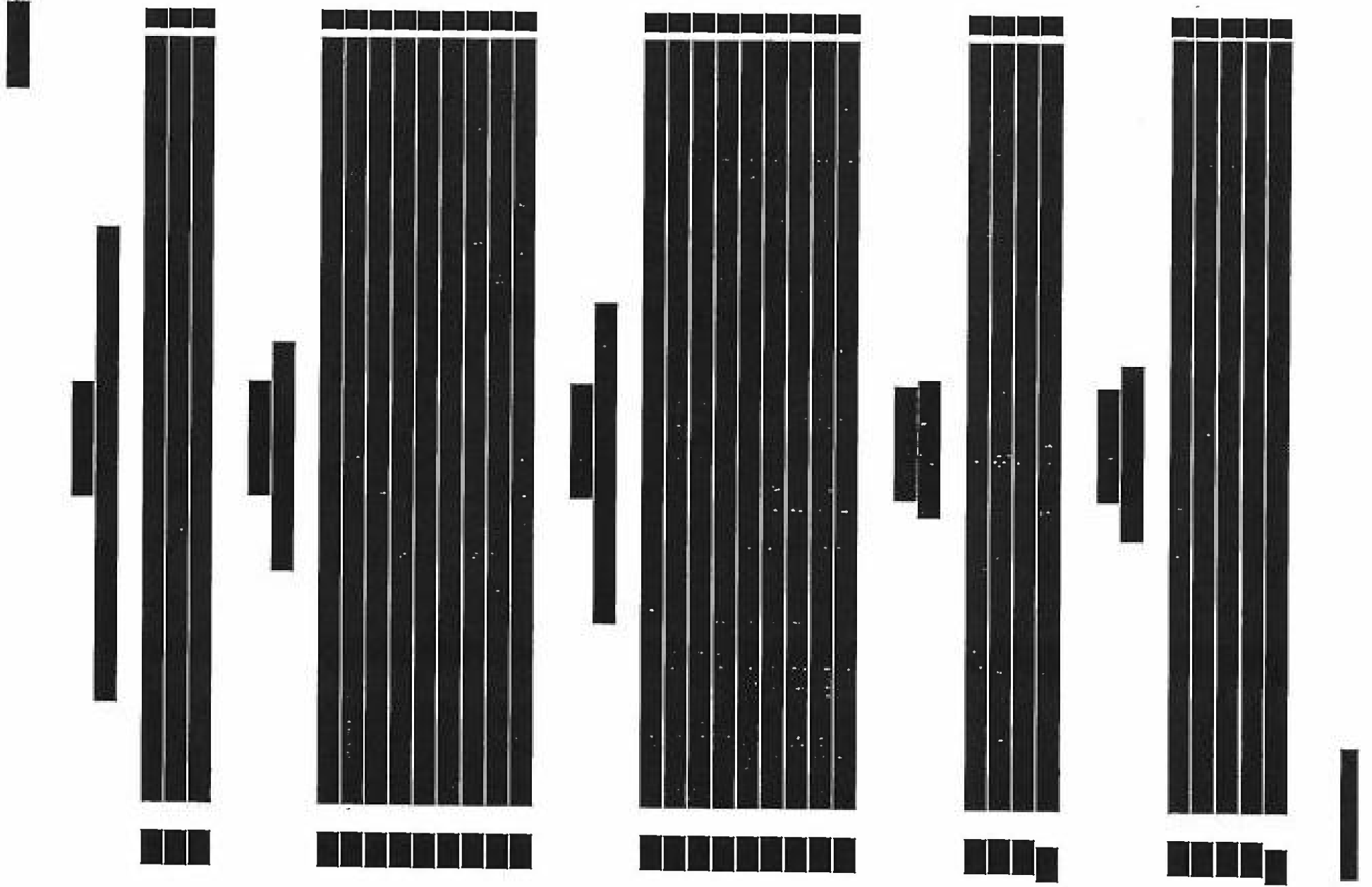
