Dear Mr. Derouen,

In January of 2013, the Commission issued an Order suspending the proposed water and sewer rate increases for Symsonia Water District in the above-referenced case until July 24, 2013. Pursuant to that Order and 807 KAR 5:076 Section 7(1), Symsonia may place its proposed water and sewer rate increases into effect subject to refund if the Commission has not issued its rate Order by July 24, 2013.

The Commission Staff has issued a Staff Report recommending approval of the proposed increases, and Symsonia is currently awaiting a Final Order from the Commission. While Symsonia hopes the Commission issues an Order approving the rate increases before July 24, 2013, this letter is to provide written notice that Symsonia intends to exercise its right to implement the rate increases effective on and after July 24, 2013 if the Commission has not issued a Final Order by that date. Attached are signed tariffs containing the proposed water and sewer rate increases.
