



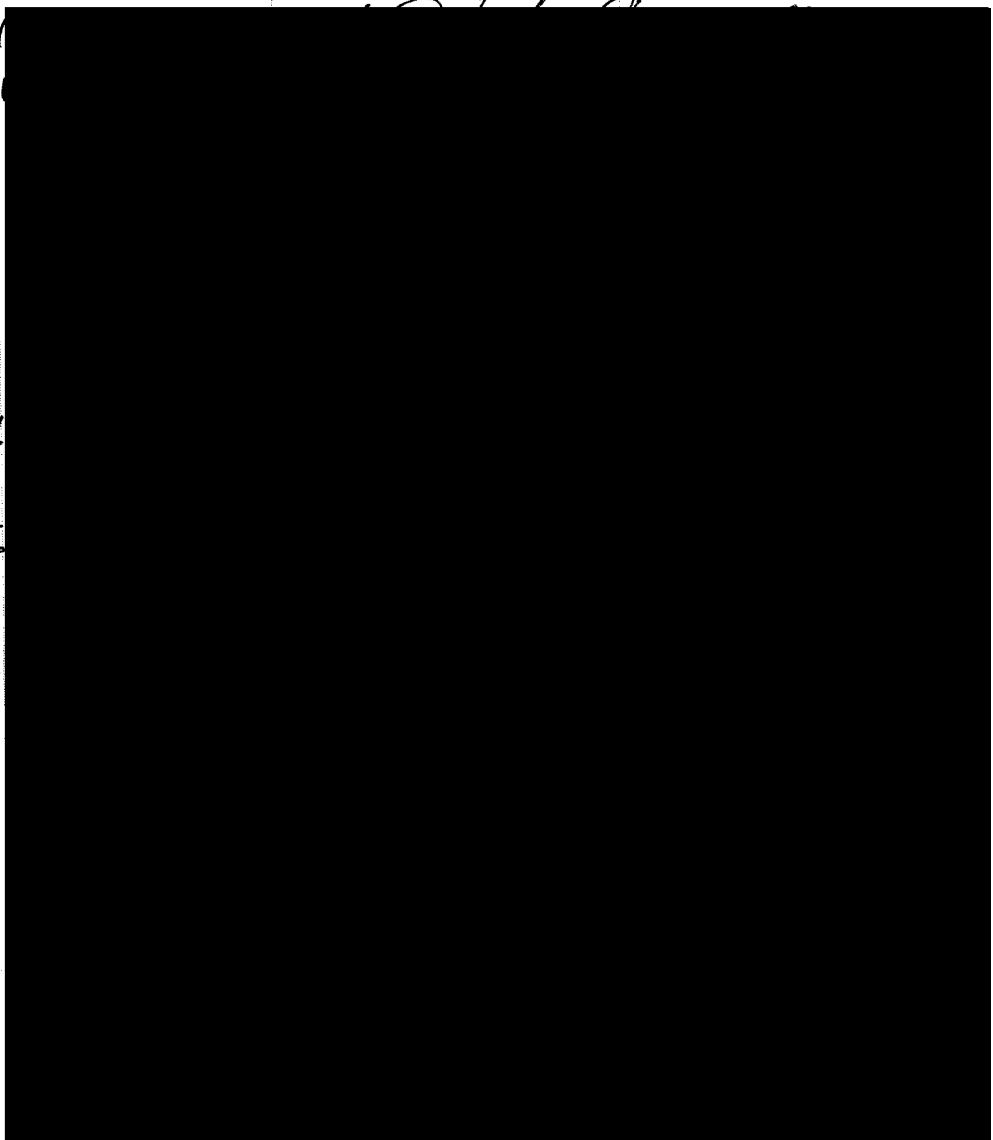
We, the citizens of Lawrence County, Kentucky, request that the Public Service Commission deny the application of American Electric Power (AEP), in closing the Big Sandy Plant located in Lawrence County, Kentucky.

Our community has enjoyed a long standing relationship with AEP and has been actively involved in community outreach since its inception in 1962.

Furthermore, the loss of jobs in the community would amount to an economic catastrophe that the community would be unable to overcome.

Lastly, the loss of tax revenue would be in excess of \$900,000 per year to the county, school board, and library among other taxing districts that receive a portion of this money. This would constitute a loss of revenue that would adversely impact the education that students receive, as well as, prohibit the county from providing necessary governmental operations including those that affect public safety and general welfare.
