ORDER

On December 20, 2012, Magoffin County Water District ("Magoffin District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Magoffin District purchases water from Salyersville Water Works ("Salyersville").
- 2. On November 27, 2012, Salyersville Water Works Commission voted to increase its rates for wholesale water service to Magoffin District.² Effective January 10, 2013, Salyersville adjusted and revised its wholesale water rate to Magoffin District from a two-step rate, in which the rate for the first 8,000,000 gallons of water purchased during the billing period is \$2.50 per 1,000 gallons and the rate for all usage in excess of

8,000,000 gallons during the billing period is \$2.65 per 1,000 gallons, to a flat rate of \$2.65 per 1,000 gallons.³

- 3. Magoffin District proposes to increase its rates for water service effective January 10, 2013 to pass through its increased purchased water costs.
- 4. During the 12 months ending October 31, 2012, Magoffin District purchased a total of 188,438,000 gallons of water from Salyersville and sold 167,950,000 gallons of water. The increase in the cost of purchased water is \$14,400 and results in a purchased water adjustment of \$0.09 per 1,000 gallons.
- 5. A purchased water adjustment of \$0.09 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 6. Magoffin District's proposed rates, which are set forth in Appendix B to this Order, reflect a purchased water adjustment of \$0.09 per 1,000 gallons as applied to Magoffin District's current rates.
- 7. Magoffin District's proposed rates, are fair, just, and reasonable and should be approved for water service rendered on or after January 10, 2013.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$0.09 per 1,000 gallons, as calculated in Appendix A, is approved.
- 2. Magoffin District's proposed rates are approved for water service rendered on or after January 10, 2013.
 - 3. Magoffin District's proposed tariff sheets are approved as filed.
