COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO JACKSON PURCHASE ENERGY CORPORATION

Jackson Purchase Energy Corporation ("Jackson Purchase"), pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies of the following information, with a copy to all parties of record. The information requested herein is due no later than May 30, 2013. Responses to requests for information shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Jackson Purchase shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or,

though correct when made, is now incorrect in any material respect. For any request to which Jackson Purchase fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.

- 1. Refer to Exhibit A of the application, PSC No. 15, Sheet No. 19, Schedule I-E. Confirm that Jackson Purchase intended to show the Demand Charge as \$14.65 and the Energy Charge as \$.035121, as shown on Exhibit C, page 1 of 2, of the Testimony of James R. Adkins ("Adkins Testimony").
- 2. Refer to Exhibit A of the application, PSC No. 15, Sheet No. 124, Schedule G-1. Explain why Jackson Purchase is not proposing to change the Renewable Resource Energy Service rates reflected on this page. If changes should be proposed, provide the rates and supporting calculations.
- 3. Refer to the first page of the Adkins Testimony, answer to Question 5. Mr. Adkins states that he will explain and support the proposed non-Fuel Adjustment Clause ("FAC") Purchased Power Adjustment ("PPA") needed to flow through the corresponding non-FAC PPA proposed by Big Rivers. No further mention of the non-FAC PPA is made in his testimony. Did Mr. Adkins intend to include additional testimony regarding the non-FAC PPA? If yes, provide the additional testimony.

4. Refer to Exhibits A-E of the Adkins Testimony. Provide revised versions of these five exhibits in both paper copy and Excel spreadsheet electronic format using the revised proposed wholesale rates provided by Big Rivers Electric Corporation in Case No. 2012-00535.1
