ORDER

The matter is before the Commission upon Kentucky Industrial Utility Customers, Inc.'s ("KIUC") petition to amend the procedural schedule. KIUC requests that the deadline for the filing of intervenor testimony be extended one week from June 28, 2013 to July 5, 2013. Due to the fact that Kentucky Power Company ("Kentucky Power") will not be able to respond to KIUC's Initial Data Request, Item No. 53, until June 28, 2013, KIUC asserts that the response could produce important information leading to a more complete understanding of Kentucky Power's proposal. KIUC's discovery requested Kentucky Power to provide the results of a recent 250 MW request for proposals that was conducted by Kentucky Power.

Kentucky Power filed a response to KIUC's petition to amend the procedural schedule. Kentucky Power stated that it had no objections to the request on the condition that the remaining procedural deadlines should be extended for one week as

well. Kentucky Power advises that it has discussed this issue with KIUC and that KIUC has no objection to Kentucky Power's conditional agreement.

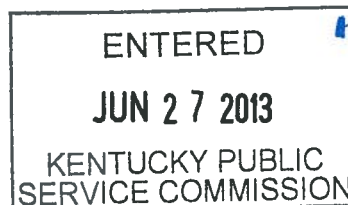
Having reviewed the pleadings and being otherwise sufficiently advised, the Commission finds that KIUC has established good cause to permit it to amend the procedural schedule.

IT IS THEREFORE ORDERED that:

1. KIUC's petition to amend the procedural schedule is granted to the extent that all intervenor testimony shall be filed by July 5, 2013, and all subsequent procedural steps shall be extended by one week.

2. The procedural schedule attached as the Appendix to this order shall be followed in this case and shall supersede the procedural schedule appended to the Commission's April 26, 2013 Order.
