ORDER

On May 16, 2013, Garrard County Water Association, Inc. ("Garrard County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Garrard County purchases water from the city of Lancaster ("Lancaster"), the city of Danville ("Danville"), and the city of Berea ("Berea").
- 2. Lancaster and Garrard County executed an amended water purchase contract in which they agreed that Landcaster's volumetric wholesale rate to Garrard County will increase from \$2.03 per 1,000 gallons to \$2.12 per 1,000 gallons on July 10, 2013.²
- Garrard County proposes to place its proposed rates into effect July 10,
 2013.
- 4. Garrard County proposes a purchased water adjustment factor of \$0.08 per 1,000 gallons.

KRS 278.012; 807 KAR 5:068.

The rate charged by Lancaster includes the base rate of \$1.96 per 1,000 gallons plus the Kentucky River Authority Fee of \$0.16 per 1,000 gallons.

- 5. During the 12 months ending April 30, 2013, Garrard County purchased 263,321,309 gallons of water from Lancaster, 85,580,401 gallons of water from Danville, and 28,149,558 gallons of water from Berea. It sold 305,599,661 gallons of water. As a result of the amended water purchase contract, Garrard County's cost of purchased water will increase \$23,698.92 and will produce a purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order.
- 6. The purchased water adjustment factor of \$0.08 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 7. Garrard County's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for service rendered on and after the date of this Order.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.08 per 1,000 gallons is approved.
- 2. Garrard County's proposed rates are approved for services rendered on or after July 10, 2013.
- 3. Garrard County's proposed tariff sheet filed with the application is approved.
