ORDER

On November 21, 2013, Sonia McElroy and Sierra Club (collectively "Sierra Club") and East Kentucky Power Cooperative, Inc. ("EKPC") filed a joint motion requesting a limited modification to the current procedural schedule to allow intervenors additional time to file their testimony and additional time for the issuance of data requests on intervenors. Sierra Club notes that pursuant to the Commission's September 20, 2013 Order, intervenor testimony is scheduled to be due on or before November 25, 2013, and data requests to intervenors are due on or before December 6, 2013.

As a result of informal agreements by the parties concerning the deadlines for the issuance of discovery requests and responses thereto, Sierra Club states that it received EKPC's responses to its data requests on November 14, 2013. The joint motion indicates that the parties have all agreed to the short extension of two days in which to file intervenor testimony and an extension of three days to issue data requests to intervenors and that the remaining procedural schedule would stay unchanged.

Having reviewed the joint motion and being otherwise sufficiently advised, the Commission finds that Sierra Club and EKPC have established good cause to permit a limited modification of the current procedural schedule.

IT IS THEREFORE ORDERED that:

- 1. The joint motion of Sierra Club and EKPC to modify the procedural schedule is granted.
- 2. The existing procedural schedule as established pursuant to the September 20, 2013 Order is amended to the limited extent that intervenor testimony shall be filed on or before November 27, 2013, and all data requests to intervenors shall be filed on or before December 9, 2013.
- 3. The remaining scheduling dates established by the September 20, 2013 Order shall remain unchanged.
