Essentially EKPC installed a double circuit 3.5 kV/138 KV line and moved three sections for a total of 14,697 feet to a new route line placement.

As a result EKPC's placement places this line the middle of our front yard, and thus the carport and garage of our home. Because of this large upgrade we receive a shock if you touch the metal on a vehicle in the driveway and the EMF levels have been as high as 23 milligauss inside our home. These lines now are only approximately 30 percent load capacity per EKPC. Since no CPCN was required Harold Barker, Ann Barker + Brook Barker were denied adequate time to investigate, file claims and have a hearing with the PSC. We are filing this claim because of the health and safety concerns we have not only for ourselves but the public because of the location of these massive transmission lines.
