## RESOLUTION

Section 3. This Resolution shall take effect immediately upon passage.



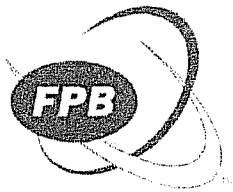
