A service charge of \$25.00 per month per meter will be made to read a customer's meter that refuses to allow an automated meter to be installed at their location(s).


and 2.) allowing Fleming-Mason to submit an application in the future for Amending it Service charge in this matter in the event the "Smart Grid Collaborative" does not address
