

The District has been told by the City of Versailles that the Kentucky River Authority (KRA) has increased the water withdrawal fee.



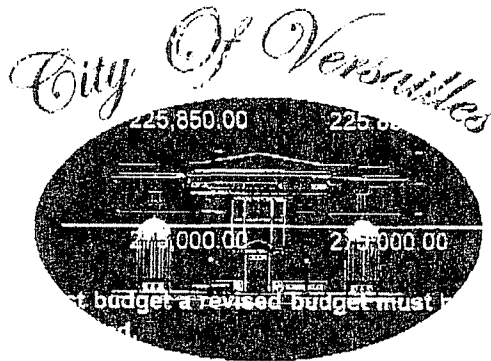

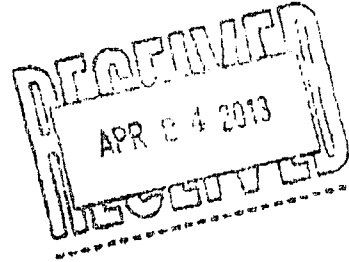
