Dear Mr. Derouen,

In August of 2013, the Commission issued a letter in the above-referenced case stating that the proposed sewer rate increase application for Joann Estates was accepted for filing as of August 22, 2013. On October 7, 2013, the Commission issued a procedural Order stating that Joann Estates may not place its proposed sewer rate of \$35.00 per month into effect "until six months from the date of the filing of its application," which would occur on February 22, 2014.

The Commission Staff has issued a Staff Report recommending approval of a proposed sewer rate that is somewhat less than \$35.00 per month, and Joann Estates is currently awaiting a Final Order from the Commission. If the Commission does not issue a Final Order by February 22, 2014, Joann Estates urgently needs to implement the proposed rate increase, and depending upon the timing of any Final Order, we may be required to expend money and time to refund the difference between the proposed rate of \$35.00 and the rate ultimately approved by the Commission.

Therefore, while Joann Estates hopes the Commission issues an Order approving the rate increase before February 22, 2014, this letter is to provide written notice that Joann Estates intends to exercise its right to implement the proposed rate increase effective on and after February 22, 2014 if the Commission has not issued a Final Order by that date. Attached is a signed tariff containing the proposed sewer rate of \$35.00 per month.
