**AMERIGAS PARTNERS, L.P. AND AMERIGAS PROPANE, L.P.'S
MOTION TO HOLD PROCEDURAL SCHEDULE IN ABEYANCE**

AmeriGas Partners, L.P. and AmeriGas Propane, L.P. (collectively, "AmeriGas") respectfully request that the Kentucky Public Service Commission ("Commission") hold this case's current procedural schedule in abeyance. On the afternoon of June 4, 2014, AmeriGas reached an agreement in principle to sell the Bright's Propane Service, Inc. propane utility to a party AmeriGas believes is qualified to own and operate the utility. AmeriGas therefore respectfully asks the Commission to hold this proceeding in abeyance—including canceling the currently scheduled June 12, 2014 public hearing—to permit AmeriGas and its counterparty to negotiate sale documents and draft a transfer application to file with the Commission.

AmeriGas further asks the Commission to issue an Order granting this request by Friday, June 6, 2014, to permit AmeriGas to send notice of the hearing's cancelation to all persons to whom AmeriGas provided notice of the hearing.

AmeriGas will apprise the Commission Staff of the transfer discussions' status as significant developments occur.

WHEREFORE, AmeriGas respectfully requests that the Commission hold the procedural schedule in this case in abeyance as described above.
