L.P. - Alleged Failure To Comply With KRS 278.020

Pursuant to the Commission's Order issued October 7, 2013, this telephonic informal conference ("IC") was initially scheduled to be held on October 9, 2013. However, due to a personal conflict of counsel representing AmeriGas Partners, L.P. and AmeriGas Propane L.P. (collectively "AmeriGas") and Energy Transfer, L.P. ("Energy Transfer"), the telephonic IC was rescheduled. On October 15, 2013, Commission Staff received an electronic message from counsel stating that she would be withdrawing from the case, and that her colleague Duncan Crosby would be representing AmeriGas and Energy Transfer instead. The rescheduled telephonic IC was held at the Commission's offices in Frankfort, Kentucky on October 16, 2013. The purpose of the IC was to discuss all outstanding issues relating to the case. A list of the attendees is attached to this memo.

Commission Staff initiated discussion by stating that Commission Staff had emailed Mr. Crosby a proposed Stipulation and Settlement Agreement ("Stipulation"), which was revised based on a draft proposed by AmeriGas's and Energy Transfer's previous counsel. Mr. Crosby stated that he had reviewed the Stipulation and proposed a minor change. He requested time to review the Stipulation with Energy Transfer's in house legal representative. Commission Staff clarified that Mr. Crosby was representing both AmeriGas and Energy Transfer, which Energy Transfer's representative affirmed. Commission Staff asked Mr. Crosby to notify Commission Staff if the Stipulation was satisfactory or if there were any significant issues, and agreed to schedule a subsequent IC if there were additional concerns to discuss.

There being no further discussions, the informal conference was adjourned.
