Allyson, Thank you for providing me with the email addresses.

We reviewed the application and the maps used were not the most current maps.

Please amend your application and re-submit the map(s) in this case.

First of all, the most recent topographic map, with signatures from 1992, should be used to show the proposed new boundary. A pdf file of that map (Keene_1992.pdf) is enclosed.

Secondly, we mapped the 4 points for revision that define the new boundaries. The points appear to match a parcel boundary along a fence line when they overlay recent imagery. However, Points A and D do not match the existing electric service area boundary file that the PSC compiled from the 1992 topographic map (see Closeup.pdf). You might consider revising the location of the intersection of the PSC lines shown in PSCLineSeg.pdf to correct this problem.

LGE-KU indicated they will use the most recent map and acknowledged that the current service boundary line may not coincide with points A & D. They are trying to notch out Lot #7.

Ruth wants the parties to confirm that the residences from point D going East are in the correct territory.

At LGE-KU's request, Ruth is providing the correct coordinates for points A & D.

Attached are the new points, labeled A2 and D2. The first pair of coordinates is expressed in NAD83 Kentucky State Plane FIPS 1600 (Single Zone), which I use to overlay the statewide imagery and quadrangles. The second set of coordinates is in NAD 83 Kentucky State Plane South and is the same as the coordinates provided on the detailed map submitted on October 7, 2013.
