

RESPONSE OF KENERGY CORP. TO MOTION BY KENTUCKY INDUSTRIAL UTILITY CUSTOMERS, INC.

KENERGY CORP. ("Kenergy"), for its response to the motion by KENTUCKY INDUSTRIAL UTILITY CUSTOMERS, INC. ("KIUC") regarding the reserve funds and rate procedure, states as follows:

- 1. Kenergy objects to KIUC's motion regarding the proposed use of the reserve funds in *this* matter. KIUC is a party to the **BIG RIVERS ELECTRIC CORPORATION** ("BREC") rate case, No. 2013-199. The Commission will determine in that action the fair, just and reasonable use of the reserve funds in light of BREC's rate increase request. Although Kenergy has not yet filed its application in this matter, Kenergy only seeks to flow through whatever the Commission decides in 2013-199. In this matter Kenergy does not propose to alter the formula for the retail rate from the wholesale rate finding in 2013-199.
- 2. This should not be a full rate case. Kenergy seeks no increase in the retail rate that is applied to the wholesale rate received from BREC. All the decisions concerning whether BREC's proposed use of reserve funds is appropriate will be made in

Case No. 2013-199. As such, it would be a waste of time to consider this action as anything but a flow through as Kenergy does not seek to increase its retail margin or alter the rate design on any class in this filing. Whatever the Commission decides in 2013-199, Kenergy simply wants to pass it along proportionately to the retail customer.
