- (A) That applicant is engaged in the business of furnishing natural gas services to the public in certain counties in the Commonwealth of Kentucky, pursuant to authority granted by the Commission.
 - (B) That applicant's full name and post office address is:

- (C) That Columbia's Articles of Incorporation previously have been filed with the Commission in Case No. 2013-00066 and are incorporated herein by reference.
- (D) That Columbia is furnishing gas distribution service in the franchise area as of the date of the filing of this Application.
- (E) Attached hereto is Ordinance No. 2013-33 passed by the City of Versailles at the December 3, 2013 Regular Council Meeting of the City of Versailles, Kentucky ("Versailles"). Said minutes reflect the decision of Versailles to advertise for bids for a natural gas franchise. Said advertisement was by legal notice published in *The Woodford Sun* on December 24, 2013.
- (F) The need and demand for gas distribution service within the corporation limits of Versailles is shown by the fact that Columbia serves approximately 2,670 customers in the city at the present time. There exists a public necessity for adequate service of natural gas to the citizens of Versailles, Kentucky.
- (G) Columbia desires to acquire said franchise for gas distribution service in Versailles and submit a bid pursuant to Versailles' published legal notice.

ORDINANCE 2013-33

ORDINANCE CONFIRMING THE SALE AND AWARDING A NONEXCLUSIVE FRANCHISE TO COLUMBIA GAS FOR THE PLACEMENT OF FACILITIES FOR THE TRANSMISSION, DISTRIBUTION AND SALE OF GAS FOR HEATING AND OTHER PURPOSES WITHIN THE PUBLIC RIGHTS-OF-WAY OF THE CITY OF VERSAILLES FOR AN INITIAL TEN (10) YEAR PERIOD WITH UP TO TWO (2) ADDITIONAL EXTENSIONS OF TIME OF FIVE (5) YEARS EACH, IN RETURN FOR PAYMENT TO THE CITY OF VERSAILLES OF THE SUM OF AT LEAST THREE PERCENT (3%) OF EACH FRANCHISEE'S GROSS ANNUAL **REVENUES FROM** THE SALE. DISTRIBUTION. AND DELIVERY OF GAS WITHIN THE CITY OF VERSAILLES AND AN OPTION TO INCREASE THE FEE TO AN AMOUNT NOT TO EXCEED FIVE PERCENT (5%); ALL EFFECTIVE ON DATE OF PASSAGE.

WHEREAS, Ordinance 2013-33, adopted by the Versailles City Council on December 3, 2013, provided for the creation and sale of a non-exclusive franchise, for a term of ten (10) years with up to two (2) additional extensions of time of five (5) years each, for the privilege of constructing, operating, maintaining and distributing natural gas along and under public right-of-way within the corporate boundaries of the City of Versailles; and

WHEREAS, Ordinance 2013-33 also established a process by which the successful franchisee would be permitted to excavate within public right-of-way for the purpose of installing and maintaining its gas transmission and distribution lines in order to furnish natural gas to the residents of Versailles, Kentucky; and

WHEREAS, after publication of said advertisement on December 11, 2013, the only bid received by the City Clerk was from Columbia Gas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF VERSAILLES, KENTUCKY, AS FOLLOWS:

Section 1. That the gas franchise created by Ordinance 2013-33 be, and it hereby is, awarded to the highest and best bidder, Columbia Gas, for the cost of advertising and sale of said gas franchise, plus three percent (3%) of its annual gross revenues, which shall be payable to the City of Versailles, Kentucky, on a monthly basis. However, the City of Versailles, pursuant to Ordinance 2013-33, reserves the right at any time, and upon sixty (60) days written notice, during the effective period of the franchise to be awarded hereby to impose upon Columbia Gas a franchise fee in an amount not to exceed five percent (5%).

Section 2. That the Mayor shall be, and hereby is, authorized and directed to execute the Gas Franchise Agreement on terms and conditions established in Ordinance 2013-33, a copy of which agreement is attached hereto and incorporated herein by reference. The effective date of the above Gas Franchise Agreement is February 1, 2014.

Section 3. All prior ordinances, municipal orders, or policies or parts thereof in conflict herewith, are to the extent of such conflict, hereby repealed.
