ORDER

On January 6, 2014, Union County Water District ("Union County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Union County purchases water from the city of Morganfield ("Morganfield").
2. On January 1, 2014, Morganfield increased its wholesale rate to Union County from \$1.6617 per 1,000 gallons to \$2.0378 per 1,000 gallons.²
3. During the 12 months ended November 30, 2013, Union County purchased 321,979,490 gallons of water from Morganfield and sold 300,729,745 gallons.
4. The increase in the cost of purchased water is \$121,096.49, as calculated in Appendix A to this Order, resulting in a purchased water adjustment of \$0.40 per 1,000 gallons.

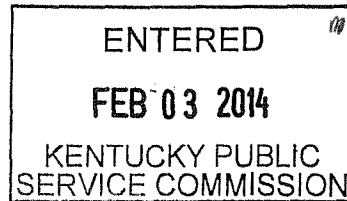
5. The purchased water adjustment of \$0.40 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Union County's proposed rates, which are set forth in Appendix B to this Order, are fair, just, and reasonable.


IT IS THEREFORE ORDERED that:

1. Union County's proposed rates are approved.
2. The purchased water adjustment of \$0.40 per 1,000 gallons is approved.
3. The rates in Appendix B are approved for services on or after January 1, 2014.
4. Within 20 days of the date of this Order, Union County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
