ORDER

On April 22, 2014, in Case No. 2013-00148,<sup>1</sup> the Commission approved rates for Atmos Energy Corporation (“Atmos”) and provided for their further adjustment in accordance with Atmos’s Gas Cost Adjustment (“GCA”) clause.

On June 27, 2014, Atmos filed its GCA to be effective August 1, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Atmos’s notice includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
2. Atmos’s Expected Gas Cost (“EGC”) for firm sales customers is \$6.5745 per Mcf, an increase of \$.3051 per Mcf from the previous EGC of \$6.2694 per Mcf. Atmos’s EGC for interruptible sales customers is \$5.2882 per Mcf, an increase of \$.3040 per Mcf from the previous EGC of \$4.9842 per Mcf.
3. Atmos’s notice sets no current quarter Refund Factor (“RF”). Atmos’s total RF is \$.0000 per Mcf, which represents no change from its prior RF. Atmos’s notice

sets out all previously approved RFs at \$0 due to Atmos's having already refunded all pipeline refunds to its customers.

4. Atmos's notice sets out its current Correction Factor ("CF") of (\$.0982) per Mcf, which represents a decrease of \$.6875 per Mcf from the previous CF of \$.5893 per Mcf.

5. Atmos's notice sets out its Performance Based Rate Recovery Factor ("PBRF") of \$.1936 per Mcf, which is effective from February 1, 2014, until February 1, 2015.

6. Atmos's GCAs are \$6.6699 per Mcf for firm sales customers and \$5.3836 per Mcf for interruptible sales customers. The impact on firm sales customers is a decrease of \$.3824 per Mcf from the previous GCA of \$7.0523 per Mcf. The impact on interruptible sales customers is a decrease of \$.3835 per Mcf from the previous GCA of \$5.7671 per Mcf.

7. The rates in the Appendix, attached hereto and incorporated herein, are fair, just and reasonable, and should be approved for final meter readings by Atmos on and after August 1, 2014.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after August 1, 2014.

2. Within 20 days of the date of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 2014-00212 DATED **JUL 18 2014**

The following rates and charges are prescribed for the customers in the area served by Atmos Energy Corporation. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

RATES:

Applicable to: General Sales Service Rate G-1

Gas Cost Adjustment

To each bill rendered under the above-named rate schedule there shall be added an amount equal to: \$6.6699 per Mcf of gas used during the billing period.

Applicable to: Interruptible Sales Service Rate G-2

Gas Cost Adjustment

To each bill rendered under the above-named rate schedule there shall be added an amount equal to: \$5.3836 per Mcf of gas used during the billing period.
