ORDER

On March 26, 2015, the Kentucky Industrial Utility Customers, Inc. ("KIUC") filed a motion in this proceeding requesting that the Commission issue an order requiring Big Rivers Electric Corporation ("Big Rivers") to respond to Item 1 of its March 6, 2015 Request for Information. KIUC also requested a telephonic informal conference so that the parties could discuss amending the procedural schedule.

A telephonic informal conference was held on March 26, 2015, at which time the parties agreed that, except for the hearing date, each of the remaining steps of the procedural schedule should be moved one week later than currently established.

Having reviewed the informal conference memo filed on March 30, 2015, and being otherwise sufficiently advised, the Commission finds that the current procedural schedule as established by our March 9, 2015 Order should be amended and that all parties should adhere to the procedural schedule attached as the Appendix to this Order. The Commission further finds that KIUC's motion to compel will be addressed

by a separate Order once all relevant pleadings related to that motion have been submitted by the parties.

IT IS HEREBY ORDERED that:

- The current procedural schedule as established by the Commission's
 March 9, 2015 Order shall be amended as agreed to by the parties at the March 26,
 2015 telephonic informal conference.
- All parties shall adhere to the procedural schedule set forth in the Appendix to this Order.
