**ANSWER**

Comes now Atmos Energy Corporation ("Atmos"), by counsel, and for its response to the Order of the Commission entered on January 9, 2014, states as follows:

1. Atmos denies that Complainant, Michael Donald Grugin, is entitled to any reimbursement as sought in the Complaint he has filed in this proceeding.

2. Consistent with the information provided to Atmos at the time of initial establishment of service, including that the property in question was classified as commercial real estate by the local Property Valuation Administrator, with Mr. Grugin listed as the owner, Atmos appropriately classified the service as commercial. A copy of the local Property Valuation Administrator's report showing that the premises are classified as commercial is attached as **Exhibit A**.

3. Upon the request for a change in the service to tenant occupancy and based on information provided to and available to Atmos at the time, service to the premises was properly re-classified as residential.

4. The Complaint states no information that contradicts or disputes the correct classification of service at the time of initial service or change of service or that Atmos acted improperly based on the information provided to it.

5. The total refund requested is barred by the statute of limitations.

WHEREFORE, having answered the complaint, Atmos requests that this proceeding be dismissed.



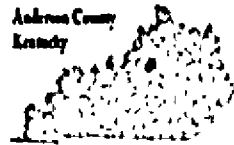
