RE: Informal Conference of April 29, 2015

Pursuant to a Commission Staff ("Staff") Notice issued on April 22, 2015, a telephonic informal conference ("IC") was conducted on April 29, 2015. In attendance were members of Staff, representatives of Big Rivers Electric Corporation ("Big Rivers"), representatives of the Attorney General of the Commonwealth of Kentucky, Office of Rate Intervention, and representatives of Kentucky Industrial Utility Customers, Inc. Attached is a copy of the attendance roster.

Staff asked for clarification of proposed changes to Big Rivers' Tariff, pursuant to the proposed stipulation and settlement agreement. Big Rivers stated that it would add language to its tariff to clarify when the Nebraska margins would not be deposited into the Economic Reserve. Big Rivers also agreed to file a sample formula of its times interest earned ratio calculation. The parties discussed the procedure going forward.

There being no further discussion, the IC was then adjourned.
