**ATTORNEY GENERAL'S MOTION FOR AN EXTENSION
OF TIME TO FILE INITIAL REQUESTS FOR INFORMATION**

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and moves the Commission for an extension of two weeks in which to file his round of discovery requests currently due on July, 24 2014.

As grounds for his motion, the Attorney General states that the Order was entered on July 10, 2014 with a July 14, 2014 intervention deadline, and a July 24, 2014 requests for information deadline. The Attorney General requires more time to evaluate Cumberland Valley Electric's new approach to the normalization of interest expense and other related requests in the determination of its revenue requirements. The evaluation will require more than the allotted ten (10) days allowed by the current scheduling order. In an effort to prepare a comprehensive initial round of request for information, the Attorney General respectfully requests an extension of two (2) weeks to file his initial requests for information currently due on July 24, 2014.


The undersigned has contacted counsel for Cumberland Valley Electric, Inc. and Attorney Hauser does not object to the motion and for the entire schedule to be moved

back by two weeks, along with the understanding that the suspension of rates remain intact based on the date of the filing.

WHEREFORE, the Attorney General respectfully moves that he be afforded up to and including August 7, 2014 in which to submit his first round of discovery requests to Cumberland Valley and that the entire procedural schedule in this matter be moved back in time by two weeks.


