
**BULLITT UTILITIES, INC.'S COMPLIANCE WITH PREHEARING ORDER**

Comes Bullitt Utilities, Inc. ("Bullitt Utilities"), and for its Compliance with the Order of the Public Service Commission concerning the formal hearing scheduled in this matter, states as follows:

1. Witnesses: Bullitt Utilities will call the following individuals as witnesses at the formal hearing and in the following order: Chris Crumpton, with BlueStone Engineers, PLLC, Lawrence Smither, as certified operator of the Hunters Hollow wastewater treatment plant and as a principle in Covered Bridge Utilities, Inc., and Chris Cogan, Attorney-in-Fact for Carroll Cogan.


