Grayson requests leave to intervene as a full intervener and requests that it be provided with copies of any filed testimony, exhibits, pleadings, correspondence already within this file or to be filed, and that it be certified as a party for the purposes of receiving service of any petition for rehearing or petition for judicial review.

The substance of the application herein directly affects Grayson insofar as it has a Wholesale Power Contract in existence between it and the applicant, East Kentucky, such that the matters raised in the within application bear a direct importance upon the terms and conditions of said Wholesale Power Contract and the owners/members of Grayson.


It is believed that the interest of Grayson's members will not be otherwise adequately represented by the applicant, East Kentucky, nor any other party hereto unless full intervention is allowed.


